It's So Easy

1. Your travel agents will set up the account with Carnival and complete the necessary paper work.
2. For each cabin booked (assumes two guests per cabin) and when the amount for the booking is paid in full to Carnival \$70.00 is placed in a donation basket (theoretically), and Carnival commits to matching that amount making each donation per cabin \$140.00.
3. Upon your return from your cruise, Carnival will require a completed *Charitable Contribution Group Amenity Claim Form* be completed and sent to Carnival's headquarters. George and Dana will have all the required data to complete the form and get it sent off to Carnival.
4. Payment is sent to the NCCC Eastern Region within 21 days of the return sailing date.
5. Regardless of the number of guests in a cabin the per cabin earnings is always \$140.00 per cabin.
Cabin assumptions:
 - 50 cabins x \$140.00 (\$70.00 donation basket + \$70.00 marched by Carnival) = **\$7,000.00 earned.**
 - 75 cabins x \$140.00 (\$70.00 donation basket + \$70.00 marched by Carnival) = **\$10,500.00 earned.**
